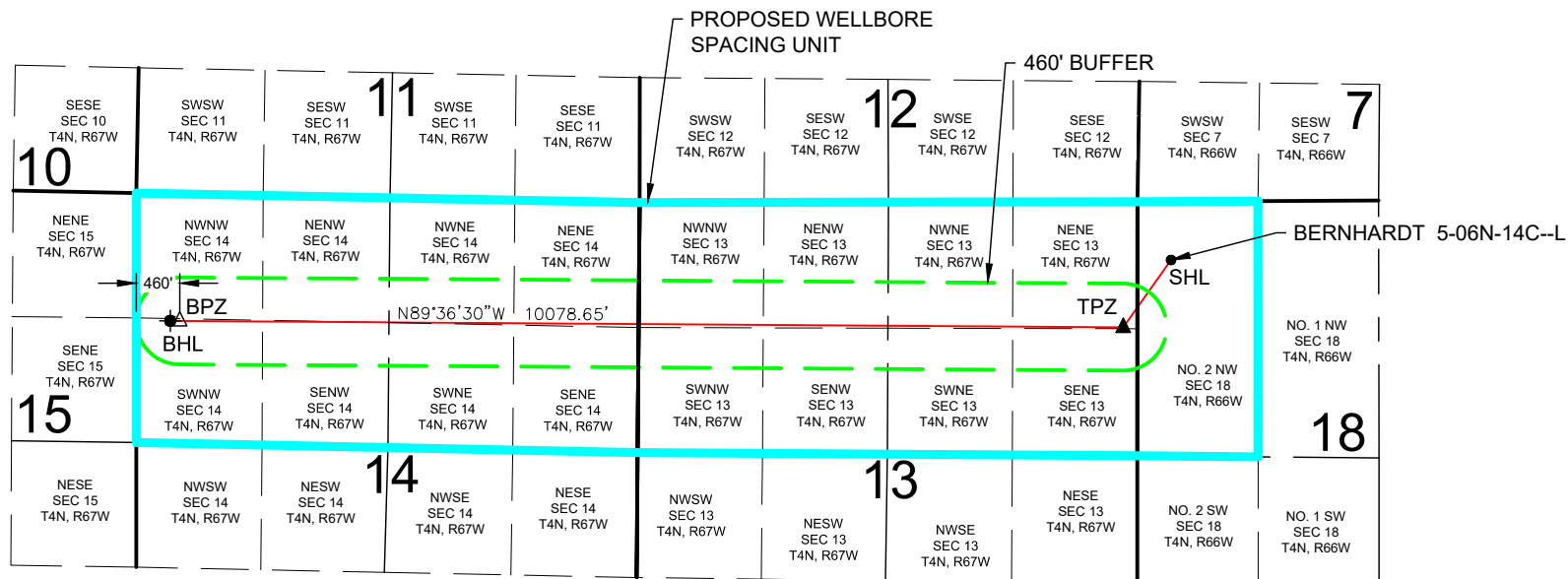

BERNHARDT 5-06N-14C-L WELLBORE SPACING UNIT

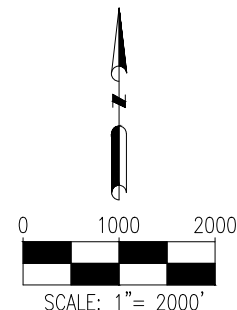


BERNHARDT 5-06N-14C-L WELL TO BE LOCATED 618' FNL AND 356' FWL, SEC 18, T4N, R66W
