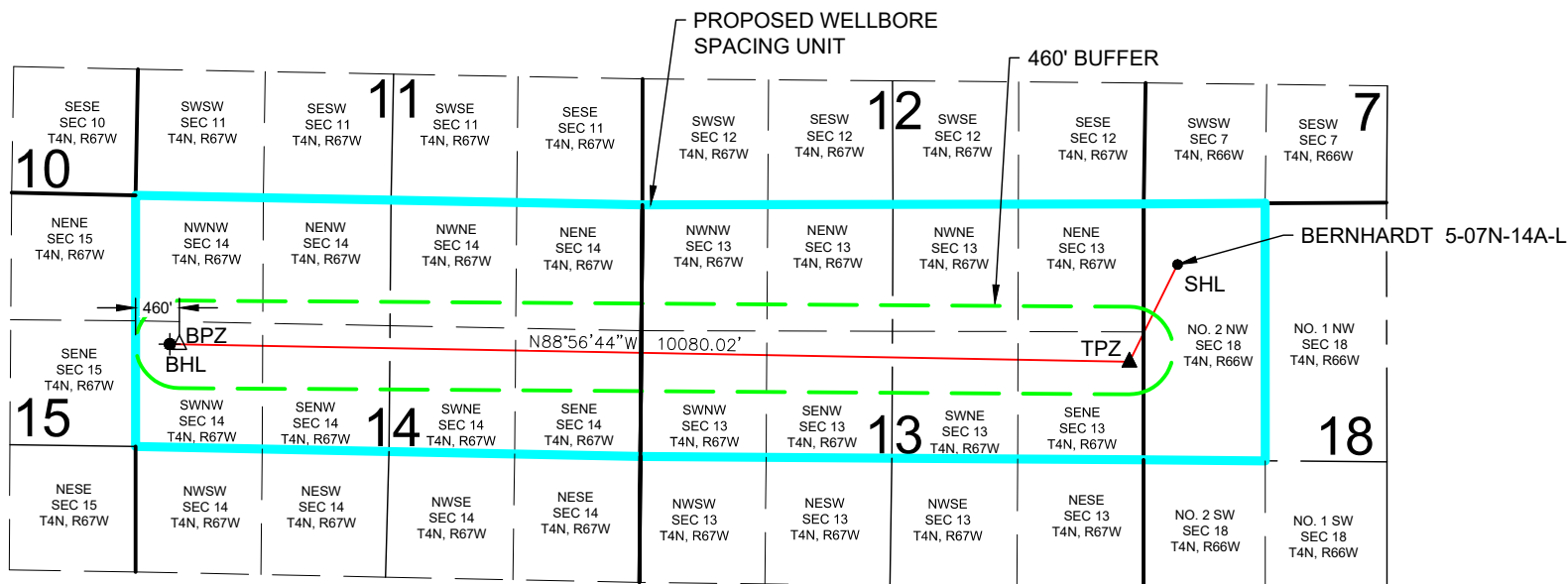

BERNHARDT 5-07N-14A-L WELLBORE SPACING UNIT

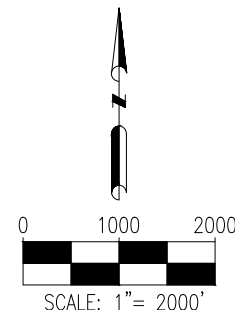


BERNHARDT 5-07N-14A-L WELL TO BE LOCATED 638' FNL AND 356' FWL, SEC 18, T4N, R66W
