General Comment:

On 4/20/2020 COGCC Staff, Kris Neidel inspected the site of spill number 449632 and Remediation Project number 10149. Chevron Pipeline Staff JC Kenney was present. Weather was 65 degrees and dry. Chevron was collecting the first samples of 2020 to monitor attenuation that has been taking place since last round of sampling. All samples were collected from 0-3" below the surface. 7 samples were collected at areas that had previously seen TPH exceedances. The spill path appeared to have been tilled in 2019 as the surface of the ground was very light compaction. There was no surface water present in the area being sampled, Division I and Division II. COGCC staff carried a shovel during the (approximate) 1500 feet of spill path observed and dug 8" into the soil to observe, no hydrocarbon staining or smell was observed. Chevron should continue to update the Remediation Project status on Form 27.
