Comments	<p>This Form 2 is being submitted as a refile of API 05-123-46647.</p> <p>There have been no new buildings constructed and no changes to the surrounding land use or mineral lease description. The well site has been constructed. The Cinnamon Teal 35-15HC (API: 05-123-46646) and Cinnamon Teal 35-16HN (API: 05-123-46650) have been drilled.</p> <p>This well did not have a sundry previously approved to move the TPZ and BHL from 600' to 300' setbacks to unit boundary, so a revised directional plan, directional data, and plat are attached to this refile. The offset well inventory and nearest outside operated well are unchanged.</p> <p>This location is not in a buffer or exception zone, so no notices are required under Rule 305.</p> <p>The Cultural Distances information is unchanged but has been updated to include School Facility information not submitted with the original permits but included in Google Spreadsheet bulk upload in June 2019.</p> <p>Local Government Information has also been added.</p> <p>The nearest well in unit and BMP's have been updated to reflect current standards.</p> <p>Nearest well in unit per anti-collision is the Cinnamon Teal 35-13HN.</p> <p>COGCC: Nearest permitted or existing wellbore belonging to another operator is the Frank 35-9 (API: 05-123-21377).</p>
