Comment:

It was documented in FIR #696200930 that utility equipment and debris remained on the Location and that a followup inspection will be required as snow cover prevented reclamation specialist from conducting an accurate assessment of the reclamation.

It was observed in this inspection that the trash debris and utility equipment has been removed. However, vegetation on the location is predominantly bare soil, not reflective of the reference, and not progressing towards 1004 revegetation standards; little desirable vegetative germination/establishment observed; additional reclamation activities is required for uniform establishment.

Corrective Action: **Comply with 1004.a; conduct additional reclamation activities to facilitate desirable vegetative establishment.**
