<p><a href="#">COGCC Inspection Report Summary</a>  On Thursday 4/30/2020 at approximately 14:00 hours, I, Inspector Tom Peterson, conducted an on-site inspection at the PDC Energy Orr 33-24 Tank Battery location #447145 in Weld County, Colorado.</p> <p>While there, I observed faded crude oil tank contents/capacity placards, AKA Midstream meter calibration card was missing, damaged access lease road to wellhead and separator. During this inspection the following possible compliance issues were observed: Rule 210.d. with a corrective action date of 7/31/2020, Rule 329 with a corrective action date of 7/31/2020, Rule 1002.f.(2)C with a corrective action date of 7/31/2020.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.</p> <p>This is a summary of the inspection report.</p>	petersont	04/30/2020
