Operator Comments:

This submittal is to provide closure documentation for the Krier #3 spreadfield. On October 22, 2019, LT Environmental, Inc. conducted post-incorporation soil sampling at the Krier #3 spreadfield. Twelve 4-point composite samples were collected throughout the spreadfield area with soil collected from 0"-6" at each aliquot. All results were compliant with COGCC Table 910-1 concentration levels, except arsenic which ranged between 2.23 mg/kg and 10.9 mg/kg. Baseline pre-incorporation arsenic results in 2014 also exceeded the COGCC Table 910-1 standard with concentrations ranging between 1.96 mg/kg and 2.62 mg/kg. Additionally, the post-incorporation arsenic concentrations are below the USGS established statewide arsenic average concentration of 11 mg/kg for the state of Colorado. The post-incorporation soil sample location map, soil analytical results summary table, and laboratory analytical report are attached.

The site has been revegetated with crop approved by the landowner which is growing without signs of distress.
