Citation Oil & Gas Corp. requests approval to retain this well in a temporarily abandoned status. The well was originally abandoned due to uneconomical oil prices. We plan on returning the well to production once an economic oil price is reached. The well has a CIBP at 5246' with 2 sxs of cement on top isolating the Morrow perms at 5296'-5300'. There are valves and plugs in the tubing and casing closing off the well to the atmosphere.
