<p><b>COGCC Inspection Report Summary</b>                      On Wednesday 5/8/2020 at approximately 11:15 hours, I, Inspector Tom Peterson, conducted an on-site inspection at the Captiva Energy Partners Mc Coy Pad 13-33 location #428105 in Weld County, Colorado.                      While there, I observed no posted battery sign, missing placards on crude oil and produced water tanks, DCP Midstream meter calibration cards were outdated, trash and weeds around location, damaged separator fence, damaged lease road and location area, stained soil at the compressor vault. During this inspection the following possible compliance issues were observed: Rule 210.b. with a corrective action date of 8/10/2020, Rule 210.d. with a corrective action date of 8/10/2020, Rule 329 with a corrective action date of 8/10/2020, Rule 603.f. with a corrective action date of 8/10/2020, Rule 907.e. with a corrective action date of 8/10/2020, Rule 1002.f.(2)A. with a corrective action date of 8/10/2020, .                      A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
