Mr. Canfield,

Our environmental consultant was on site yesterday and took the attached pictures. They show the KPK produced water tank in an open excavation with an accumulation of water at the excavation base, and stockpiled soil in the background, likely excavated from around the tank.

The produced water tank remains as it was when the COGCC issued KPK a Notice of Alleged Violation (NOAV) in 2019. See attached COGIS NOAV report.

This email follows my request from a week ago for COGCC action requiring prompt remediation and soil excavation by KPK. The current state of contamination and failure of KPK to take action in response to the COGCC's NOAV and BLC's complaints related to soil and groundwater contamination on its property remain legitimate risks to public health, safety, welfare, and the environment and prevent planned surface development to the substantial detriment of BCL.

I look forward to hearing from you on this matter.
