During decommissioning operations at the McDermid 2-1 facility crews discovered soil impacts in the vicinity of the produced water vault due to a historical release.

Eleven grab soil samples were collected by Fremont Environmental and submitted to a certified laboratory for analysis of TPH-DRO by EPA Method 8015, TPH-GRO, BTEX, and Naphthalene by EPA Method 8260b. Additionally, N. Wall 2FT was analyzed for SAR by Soluble Nutrients by EPA 6020/USDA60 (2,3A)- Dry Weight Basis, pH by Physical Parameters by APHA/ASTM/EPA Methods, and EC by EPA Method 120.1.

The source will be removed through excavation prior to November 20, 2020. Fremont Environmental will be on location to field guide the excavation and collect confirmation soil samples above the phreatic zone for analysis of TPH-DRO, TPH-GRO, BTEX, and Naphthalene. Overburden will be sampled every 500 cu/yds to ensure compliance with COGCC regulations.
