Comment:

Previous inspection documented that snow cover prevented an accurate assessment of the Reclamation. It was observed in this inspection that reclamation is in process; Desirable vegetative germination is evident though the majority of plants on Location are undesirable weedy species such as Cheat Grass. There are areas on the southern end of the Location where no germination was evident; These areas will likely require additional seeding. A follow up inspection will be conducted in a future growing season to determine compliance.

Continue to monitor and manage the Location for reclamation, stormwater and weeds until receiving a passing final reclamation inspection.
