Request to flare is being made as a result of Anadarko shutting down their Third Creek Gathering System which was the gas sales outlet for the Whitehead 4-13. An average of 2 MCFD is being combusted at the central tank battery combuster. A recent gas sample has been attached where 1 1/4 PPM hydrogen sulfide was tested.

**Operator Comments:**

This flaring request is made necessary by the shutting down of the Anadarko Third Creek Gathering System. The Whitehead 4-13 is making approximately 1 1/2 BOPD and 2 MCFD. Oil revenue dominates the economics of the well. Expansion of a new gathering system being built in the area and the sale of Anadarko assets to Oxy are possible positive developments that gas sales could be reestablished in the future. This request is for an additional year beyond a previously approved Sundry request (Document No. 401672985). COA of that Sundry approved by Stuart Ellsworth on 9/28/2018 will be adhered to.

	1) Flaring of natural gas shall comply with COGCC Rule 912. 2) Submit requests to flare annually to COGCC on Form 4 (Sundry Notice), which discusses timing to connect to sales line, plans to develop infrastructure, and justification for continued venting/flaring. Provide gas analysis including H2S with each Sundry Notice. 3) Report metered flaring volumes on Form 7, Operator's Monthly Report of Operations.  4) The operator is required to obtain and maintain any required air permits from CDPHE. 5) The expectation for permanent flares controlling separators will be an enclosed combustion device with a 98% design destruction efficiency for hydrocarbons. Operator shall manage this well so that production volumes do not exceed the combustor capacity. 6) Notify the local emergency dispatch or the local governmental designee of natural gas flaring.
