Upon review of COGCC spill document number 2222073, Caerus determined the spill was approximately 7 barrels of drilling mud spilled onto the location surface. Sampling activities were outlined as attachments to the Initial Form 19, but supplemental forms were not submitted to include the laboratory analytical results. Caerus is providing the results of the sampling event which demonstrates compliance with COGCC Table 910-1 standards except for pH, please see the attached lab report and tabulated laboratory data. To address the elevated pH concentration found on the active pad surface, Caerus requests relief under FAQ 32 consideration found on the attached narrative.
