While there, I observed normal production operations.

During this inspection the following possible compliance issues were observed: Access road has not been maintained. See photo #0825 and #1233 with a previous corrective action date of 9/2/19. Debris around equipment and inside pit. See photo #0818, #1234, #0823 and #1236 with a previous corrective action date of 4/1/20. Flow line risers not LO/TO. See photo #0820 and #1237 with a corrective action date of 3/26/20. No pit permit on file. With a previous corrective action date of 4/9/20.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
