Comment:

There has been recent reclamation work performed at the location. Areas of the location have been tilled and seeded. Straw mulch has been applied to the seeded areas. Did not observe seedling establishment during inspection but the work appears to have recently been performed. A perimeter fence has been installed around the location. Soil decompaction appears to have been performed however, it is uncertain if soils were cross ripped to a depth of 18 inches. Previous corrective action has been performed. Operator will need to monitor and manage the location to ensure successful reclamation is achieved.
