Refer to document #699800784 inspection conducted on 3/25/20. Not all previous corrective actions have been completed.

While there, I observed normal production operations.

During this inspection the following possible compliance issues were observed: Access road has not been maintained. See photo #0826 and #1238 with a previous corrective action date of 9/2/19. Debris around equipment and inside pit. See photo #0832, #1240, #0829 and #1241 with a previous corrective action date of 8/10/19. No pit permit on record. With a previous corrective action date of 8/15/19. MIT required on well. With a previous corrective action date of 4/25/20.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
