Noble Energy respectfully requests continued TA status. The well is closed to the atmosphere via equipment removed from surface on 08/06/2018. The well is locked out and tagged out at the master valve. The well was completed in the Niobrara-Codeell formation. This well was TA'd due to long term-shut in. This well is part of the AOC (Order No 1V-668) and the bradenhead pressure will be monitored and action taken as necessary as outlined in the AOC. Noble is currently working through a large back log of P&A work for offset mitigation work for DJ basin activity. Form 5A to change the status to TA was submitted on doc # 402366548. This well is tagged with a yellow tag.
