Six grab soil samples were collected during site investigation activities and submitted to a certified laboratory for analysis of TPH-DRO by EPA Method 8015, TPH-GRO, BTEX, and Naphthalene by EPA Method 8260b. Additionally, soil sample N Wall 3FT was also analyzed for SAR by EPA 6020/USDA60 6(2, 3A) - Dry Weight Basis, EC by EPA Method 120.1, and pH by APHA/ASTM/EPA Methods.
