Comments

In Spacing Tab, The distance to the nearest well completed or permitted in the same formation was measured to the ANSCHUTZ EQUUS FARMS 4-62-28-0108CNB (05-123-43694) is 448 feet. However, nearest well in same formation would be Anschutz Spring Lake 09-20H at 42 feet but the well is in AL status.

In Drilling Tab, distance from the proposed wellbore to nearest existing or proposed wellbore belonging to another operator was measured to the ORR #14-20 (APIR# 05-123-09247) (DA Status) Operated by Beaver Mesa Exploration CO (6988) using footage callouts at 77 feet. However no stimulation consent required as well is DA status. This distance is measured in 3D.

This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the 460' unit boundary setback. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.

Where inclination, MWD or gyro surveys of the offset wells are available, or can be reasonably obtained by the operator, such surveys will be incorporated in the risk analysis, taking into account survey instrument margin of error. For the proposed well, upon conclusion of drilling operations, an as-constructed final directional survey will be submitted to the COGCC with the Form 5.
