#### COMMENTS:

PDC would like to remediate bradenhead pressure by commissioning a bradenhead abatement system that combusts bradenhead gas via VRU system with bradenhead gas routed to a working tank to keep pressure below the 50 psi threshold. The system will be commissioned within 3 months of sundry approval and in place for 6 months, at which time PDC will complete a reevaluation of pressure to determine if further mitigation is required.
