During annual testing for 2020 this well was found to have BH pressure exceeding the actionable threshold for surface casing set below 455'. We would like to plumb the BH to a temporary tank for up to a 6 month period to keep the pressure below 50 psi in hopes that the pressure dissipates. After the blowdown period we will conduct a build up test a re-evaluate if further action is required.
