The well is closed to the atmosphere and locked out and tagged out at the master valve. The well was completed in the Niobrara-Codell formation. This well was TA'd for P&A. The P&A has started; however, it is now being monitored on Noble's problem well list. The form 6 SR will be submitted when the well has been cut and capped. Form 5A to change the status to TA was submitted on doc # 402420735. Initial Pressure Test is attached. This well is tagged with a blue tag.
