COMMENTS:

On 4/28/2020, a Form 17 was completed with a beginning pressure of 27 psi and it blew down to 0 psi. The well dribbled oil during the test on 4/28/2020 and for this reason Noble proposes to P&A this well by 10/15/2020. Mitigation efforts were not taken immediately after the the Form 17 bradenhead test conducted on 3/28/2019 and has since been disclosed to the COGCC through a self-report.

Engineer	<p>Returned to draft: Originally submitted on 5/7/2020</p> <p>This sundry speaks to the 4/28/2020 BH test, but doesn't mention that 'oil dribbled' during the test. The liquid production is what requires the sundry to be filed in the first place and should be mentioned. The mentioned 27 psi which blew down to 0 in and of itself wouldn't have even warranted a sundry being filed.</p> <p>Additionally, it needs to be acknowledged that the 2019 test, conducted on 3/28/2019, also showed pressure above threshold values and produced oil. Any bradenhead mitigation efforts (or lack thereof) which have been carried out since March 2019 should be discussed.</p> <p>Remove the statement that the form 17 is attached. The 17 was submitted separately and is not attached to the sundry.</p>	06/12/2020
