Timeline of amendments to location to bring into compliance (includes talks with Town of Frederick):  
9/12/19-Began researching how to amend the location with the Town of Frederick and the COGCC  
9/25/19-Internal meeting to discuss how to move forward with amendments and constraints with the location.  
Ordered revised drainage plan from surveyor/engineer that originally designed the pad.  
10/9/219-Field Work was completed, updated drainage plan was started.  
11/20/19- Reached out to the Town of Frederick to setup a meeting.  
12/2/19-Meeting with Town of Frederick to discuss amending USR to accomodate pond and revised landscaping

plan. Determined we needed FRICO approval to move forward with plan.  
 12/19/19-FRICO sent development standards to engineer. FRICO was really sluggish in response to our questions.  
 1/7/20-Town of Frederick said we could drain to the borrow ditch if we restrict flows if FRICO will not allow runoff into their ditch.  
 1/16/20-FRICO responded and said they will not allow stormwater from our pad to enter their ditch.  
 1/22/20-Came up with plan to utilize a ditch berm combo to direct stormwater to borrow ditch, but needed approval from SO and gas easement owner.  
 2/3/20-Sat down with team to discuss ditch/berm plan. Action items were assigned.  
 2/24/20-Due to staff reductions additional meeting was held.  
 3/10/20-Kinder Morgan would not give us clearance to put a berm or pipe over the top of their easement.  
 4/7/20-Received approval from Town of Frederick to utilize retention pond.  
 4/10/20-Town of Frederick advised us to use Mile High Flood District criteria for retention pond resizing.  
 4/14/20-Town of Frederick advised us we could utilize a dry retention pond design that would require a percolation test.  
 4/30/20-Began reaching out to multiple vendors for bids on percolation test and drainage letter.  
 5/26/20-Recived multiple bids and selected engineer for drainage design.

Due to staff reductions we are unsure when the adjacent surface owner was last constulted. We will reach out to the adjacent SO before the next weekly update.
