Comments: TEP Rocky Mountain LLC (TEP) is proposing to reconstruct and expand the existing Federal RGU 23-7-297 pad to support well completions operations for the sixteen (16) proposed wells to be drilled on the Federal RG 41-18-297 pad (Loc ID #316591, Amended Form 2A Doc #402342785), and support future drilling operations on the location. TEP will build the drilling pit at this time since the excavated material is needed to build the fill side of the pad. No	BMP/COA Type	Description
1	Planning	Prior to submittal of the Oil and Gas Location Assessment (Form 2A), TEP conducted onsite and meetings with the Bureau of Land Management (BLM) and Colorado Parks and Wildlife. These onsite and meetings were held to discuss TEP's proposed development plan for remote frac operations on the RGU 23-7-297 pad. Changes were made to the proposed development plan based on feedback received from all stakeholders and included in the APD/Form 2A. The development plan for the RGU 23-7-297 pad was prepared in a way that minimize surface impacts to the greatest extent possible by utilizing existing locations and using these facilities for multiple functions.
2	Pre-Construction	Prior to commencement of construction activities, TEP will hold a pre-construction meeting with contractors to review proposed site construction and installation of stormwater control measures. The site will be staked for construction prior to pre-construction meeting. Staking will identify the boundaries of the proposed site to protect existing vegetation in areas that should not be disturbed.
3	General Housekeeping	Storage of material and fluids on location during construction and completions operations will be conducted in a neat and orderly manner with regards to potential fire hazards on site. The well site and access road will be kept free of trash and debris at all time. Disposal of garbage and trash will occur approximately once per week during completions operations.
4	Storm Water/Erosion Control	Stormwater BMPs will be in place during all phases of development to control stormwater runoff in a manner that minimizes erosion, transportation of sediment offsite, and site degradation. Stormwater BMPs will include perimeter controls such as sediment traps, diversion ditches, check dams, waddles, and other control measures necessary to control stormwater run-on and run-off and minimized offsite movement of sediment. Stormwater BMPs will also include site degradation control measures such as grading, slope stabilization methods (i.e. seeding, mulching, surface roughening), perimeter berms, surfacing materials (i.e. gravel), and others necessary to minimize site degradation. Stormwater controls will be installed with consideration given to worker safety, wildlife, and site access. A post-construction stormwater program will be developed for the facility as required per Rule 1002.f.(3). Stormwater is also addressed under a field-wide Stormwater Management Plan (CDPHE Certification COR404628). Please see the construction layout for the planned stormwater BMPs proposed for installation at the site for further details.
5	Dust control	Fugitive dust control measures will be employed during all phase of development to minimize dust pollution. Dust control measures include but are not limited to the application of fresh water via water truck along access road during construction and completion operations, speed restrictions, periodic road maintenance, road surfacing (i.e. gravel), and automation of wells to reduce truck traffic. Dust control measures will be employed on an as needed based during all phases of development.
6	Construction	All construction equipment and materials will be contained within the proposed limits of the oil and gas location, access roads, or pipeline corridors. Topsoil will be stripped from the site and segregated from subsoil for reuse during pad reclamation. Fugitive dust control measures will be implemented as described in the dust control section.
7	Drilling/Completion Operations	Water used for remote completions operations will be transported through existing and proposed pipelines minimizing vehicle traffic on existing roadways. TEP will ensure 110 percent secondary containment for any volume of fluids contained at the well site during completions operations.
