#### COMMENTS:

XOG request an exemption from Rules 605.a.5 and/or 605.a.6 per Rule 602.g. The seperator and tank were in the current position when XOG acquired this lease December 1, 2005. From the historical files it appears that the previous operator did not move either the seperator or tank since acquiring them March 1, 1996, nor did XOG find indication that they were moved prior to that. The well was spud in 1985. The current configuration has been in place for many years without a safety incident.

Note the original response was submitted 7/13/16 but apparently did not go through, then again 8/3/16 in response to Insp. Doc #673403387 when put on hold pending COGCC engineering staff review. This current submittal and request is in response to Insp. Doc #689803228 of 11/1/19.
