While there, I observed a shut in facility.  During this inspection the following possible compliance issues were observed:  1. Stained soil at each pumpjack. Conduct maintenance on equipment, cleanup stained material and review self inspection processes PER RULE 1002.F.(2).D. (Corrective Action Date: July 23, 2020) See attached photos #1-8.</p> <p>A phone call was made about unused equipment on location and agreed the operator may leave it on location, operator needs this equipment when pumpjacks are put back line.  A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
