This proposed well has an approved location ID 474768.

This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback of 460' FNL and 1595' FEL of Section 24. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.

In Spacing Tab, distance is 797 feet to PURCELL 6-62-25-6005B a newly proposed well on this same pad using Plan View Map Measurement. In Drilling Tab, distance is 963 feet to State Antelope T-1-36XRLNB (05-123-41154) using 3D measurement. No stimulation consent required.

The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without openhole logs shall state. 3	Drilling/Completion Operations	Prior to drilling operations, HighPoint will perform a risk analysis of the potential for subsurface collision with existing offset wells within close proximity of the proposed well, taking into consideration the possibility of well path drift for both the existing and proposed wells. Where inclination, MWD or gyro surveys of the offset wells are available, or can be reasonably obtained by the operator, such surveys will be incorporated in the risk analysis, taking into account survey instrument margin of error. For the proposed well, upon conclusion of drilling operations, an as-constructed final directional survey will be submitted to the COGCC with the Form 5.
