Debris- All debris was removed from the pad.
Degradation of pad surface- RMNG spread gravel stockpiles over pad and cleaned up tire ruts.
Sediment migration- The roadside ditch that COGCC identified on the inspection was completed by USFS. They installed this ditch along the cut slope to allow drainage, but minimize runon to site pad. RMNG did not alter this pad.

Sediment piles with no BMPs- Stockpiles of gravel were spread across site.
Ruts and tracking- cleaned up by spreading gravel over site.
