When the partially buried PW vessel has been removed we will investigate the soil under the vessel for any impacts (visually and with a PID). If impacts are apparent we will remove impacted soil. If no impacts are apparent or impacted soil has been removed, we will pull confirmation soil samples for analysis. We will take a grab sample from the north south east and west of the vessel area, 4 samples total. Backfilling will not occur until confirmation samples are returned within 910 acceptable concentrations.
