"Noble has performed one blowdown on the Moser H34-15. The blowdown was performed on 12/4/2019, started at 43 psi and collected 0 mcf of gas and 2 gallons of fluid. On 3/4/2020, a Form 17 was completed and submitted with a beginning pressure of 19 psi. A bradenhead and production gas sample was collected during the Form 17 and will be submitted.

We are electing to P&A rather than continue with the monitor and blow down program. This well cannot be P&A'd in 6 months due to the well being located in crop, but will be P&A'd by 12/30/2020."
