 While there, I observed normal production operations. All C/A(s) from previous inspection document # 689302575 have been completed.
 During this inspection the following possible compliance issues were observed:
 • Staining next to tank
 • Wheel valve on well head casing side is leaking gas, can hear it when I got on location.
 Refer to photograph of observed compliance issue.

I tried to reach Deb Lemon with no answer, I left her a message. I then spoke with Doug Wagoner, pumper with Mustang and explained to him about the leak on the well head. He was going to go to the location and attempt to fix the leak. Doug also said that he would be in touch with me to let me know the status of the problem.
 A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
