Comment: The vegetation has not adequately reestablished at the location. There is an area bare of vegetation approximately 80'x20'. Soils need to be evaluated for potential issues such as compaction. Proper soil decompaction needs to be performed by cross ripping to a depth of 18 inches. Additional seeding should be performed to facilitate vegetation establishment. Extended corrective action date is provided for a fall seeding.
