The FWKO is enclosed by an earthen berm 20" in height that encloses a space that is 20ft by 30ft (rectangle).</p> <p>Both areas are very flat, although the battery is close to the road that has ditches available should there be any significant rain or runoff.</p> <p>If the project is done successfully (a commercial well), lease will be inspected 7 days a week by the pumper for any issues. A field foreman will also check location at least once a week.</p>
