Staff finds that, in their current form, they are protective of public health, safety, welfare, and the environment, with the below conditions of approvals. Below is a summary of Seven locations for which Caerus is requesting a 1001.c variance.</p> <p>Milholland Loc#312391-Doc#401681918 Requesting a variance of select requirements of rule 1004.a, regarding access road.</p> <p>Conditions of Approval:</p> <p>COA #1 - All corrective actions identified on a field inspection report must be performed by the corrective action date as a condition of approval for this variance until final reclamation is passed.</p> <p>COA #2 - Continue to monitor and manage the site for erosion, weed control & establishment of vegetation until final reclamation is passed.</p> <p>COA #3 - Establish 80% vegetation cover of reference area levels, except on the access road.</p> <p>COA #4 – Approval of Variance does not relieve the Operator of enforcement if they are not conducting proper, revegetation, weed, and stormwater management until final reclamation is passed.</p> <p>COA #5- Approval of the variance does not absolve the operator from enforcement due to any past non-compliance of the reclamation rules for the subject location.</p> <p>Staff believes there is no further action required by Upper Management unless you would like additional information or any action to occur on staff's part.
