Comment:

Operator has re-installed fencing around the perimeter of the tank battery. Final reclamation has been performed but additional reclamation activities will likely need to be performed, as germination of desirable species was not uniform. Weed management will need to be performed soon.

Operator indicated during a phone conversation that weed management was scheduled and additional reclamation to reseed would occur later in the fall.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards.
