Form 6(s) #401491679 shows well was plugged 11/3/2017; Pursuant to Rule 1004.a, all reclamation work was required to be completed by 11/3/2018.

It was observed in this inspection that production equipment has been removed from the Location, however final reclamation, including but not limited to, removal of gravel, compaction alleviation, recontouring, regrading and revegetation activities have not been conducted on the Location and access road in accordance with Rule 1004.a.

Corrective Action:

Two corrective actions are being applied:

1) Conduct final reclamation, including but not limited to removal of gravel, compaction alleviation, recontouring and regrading on the Location and access road, and implement temporary stabilization BMPs by 7/25/2020 until revegetation activities can be conducted.

2) Conduct revegetation activities. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Implement BMPs to stabilize the seeded soil. Revegetation activities are required by 11/1/2020 to allow for a more favorable seeding window.
