#### COMMENTS:

After a Form 17 bradenhead test, Crestone completed several blowdowns on a regular schedule, per consultation with COGCC per an approved Form 4 sundry. The bradenhead pressure has remained below 50 psig. Therefore, further mitigation is not necessary, and the well will remain part of the annual testing program. Blowdown pressure data are shown in the attached chart. A follow-up Form 17 bradenhead test was completed as further demonstration of effective blowdowns.

Form 17: 11/21/19 - 402250768 SCP=98 TP/CP=136/220, Annual - blew down to 0 psi, samples=gas
