While there, I observed a shut-in location.

During this inspection the following possible compliance issues were observed:

Review of monthly operations records indicate operator is delinquent in submitting monthly operations reports. Last production reported June 2019. Well shut in at time of inspection. Submit required Form 7(s) to COGCC per rule 309 by 5/18/2020.

No stormwater BMPs apparent. Sediment migration on and off access roads present field wide. Install or repair required BMPs per Rule 1002.f.(2)C by 7/13/2020. See photo 2.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report 689804292.
