Corrosion holes forming in upper half of northern tank see photos 2 and 3. Securely fasten all valves, pipes, and fittings to ensure good mechanical condition, inspect at regular intervals and maintain in good mechanical condition per Rule 605.d OR Comply with Rule 603.f by 7/3/2019. Noxious weeds on location. See photo 4. Comply with Rule 603.f by 7/10/2020.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
