<p>COGCC Inspection Report Summary On Monday 7/6/2020 at approximately 14:30 hours, I, Inspector Tom Peterson, conducted an on-site inspection at the KPK Montgomery 1-27 location #322747 in Weld County, Colorado. While there, I observed stained soil around the wellhead, unused wellhead fencing and outhouse near the wellhead. During this inspection the following possible compliance issues were observed: Rule 603.f. with a corrective action date of 8/7/2020, Rule 907.e. with a corrective action date of 8/7/2020. A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
