Operator Comment: The last 3 wells associated with the Kugel 42-18 battery (location ID 434798) were plugged and abandoned 09/11/2019. All equipment was removed starting 11/01/2019 and completed that month. The flowline segment for the Kugel 42-18 that ran underneath the sound walls for the Kugel 18H-H267 remained in place because it could not be safely removed until the walls were removed. The walls were removed in February 2020. Per 1105.d pre-abandonment notice was originally submitted 1/27/2020 under document number 402295644. LGD and Landowner notifications were made on 3/3/2020, to satisfy the new requirements of 1105.d.(3). COGCC integrity engineers were notified of notifications on 3/23/2020. The Form44 was still waiting approval on the date the location was inspected. Crestone emailed the COGCC on 04/06/2020 requesting approval (received 04/08/2020 doc# 402295644). The flowline has been removed and the area reclaimed (photos attached).
