Comments: *Notes assume there is a deeper, buried bradenhead valve that was inaccessible during site visit. Dug out intermediate casing valve. Needle valve and old gauge observed. Remove gauge. Intermediate on vacuum. Open intermediate casing and no flow observed. Landowner on location during test. Significant excavation would be necessary to expose bradenhead valve and allow for test.
