See attached. Flowline blew out pinhole leak during MIT on 4/8/2020. Repaired and flushed with produced water on 4/9. Oily soil stockpiled adjacent to excavation to repair flowline. Follow-up delayed by Covid-19 concerns. Samples collected from beneath excavation of pipeline and from soil stockpile on 6/11/2020 by LT Environmental and analyses performed by ALS Environmental. Location of flowline leak is Latitude/Longitude = 40.095090/-108.907918.
