On Wednesday 06/03/2020 at approximately 11:30, I, Inspector Emily Waldron, conducted a field inspection at Wolverine Resources LLC Counts 22-30 at 05-081-07358 in Moffat County Colorado.

While there, I observed a shut-in location.

During this inspection the following possible compliance issues were observed:

Incomplete or missing tank labels. See photo 2. Install sign to comply with Rule 210.d by 8/17/2020.

Annual weeds on location. See photo 2. Comply with Rule 603.f by 7/16/2020.

Insulation and top peeling off tank. See photo 3. Securely fasten all valves, pipes, and fittings to ensure good mechanical condition, inspect at regular intervals and maintain in good mechanical condition per Rule 605.d by 7/30/2020.

Well is overdue for Mechanical Integrity Test. MIT requires 10-day notification via Form 42. Well plugging requires an approved Form 6 Intent to Abandon to Plug Well. Produce well after performing successful mechanical integrity test per Rule 326 or plug well. To maintain shut-in status, the well must be able to demonstrate ability to produce without mechanical intervention by 7/16/2020.

Review of monthly operations records indicate operator is delinquent in submitting monthly operations reports. Last production reported June 2019. Well shut in at time of inspection. Submit required Form 7(s) to COGCC per rule 309 by 7/16/2020.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
