We are changing this from a full rigless to a partial rigless. We will be pulling the tubing with the rig and then proceeding from that point rigless.

Here are the two significant changes:

- Set CIBP at 7262' (50' over Codell perfs) and dump bail 2 sks
- Set CIBP at 6926' (50' over Nio formation top) and dump bail 2 sks.
