On July 9, 2020, COGCC Staff John Heil conducted an environmental field inspection of TEP ROCKY MOUNTAIN LLC (TEP operator #96850) Location ID 335602 Federal 23-6-297 and Spill/Release ID 477183.

Comment: 7/7/2020 A corroded carbon steel bushing located within the pump house spilled/released produced water. The produced water traveled south over the facility lease road and pooled in a shallow depression. See Form 19 Doc #402439440 Spill/Release ID 477183 for more information. 7/9/2020 Erosion rills were present on the south side of the facility access road. Beyond the access road was an area with mud cracks where the spilled/released fluids appeared to have pooled. Potential impacted material (stained soil) was observed in the area where the fluids had pooled. A detectable hydrocarbon odor was present at time of inspection.
