Comment	Approximately 2000 Russian knapweeds observed throughout the interim reclamation areas. Revegetation is progressing, although, additional seeding will be needed to control weed infestation. See below.
Corrective Action	Control weeds at the appropriate time, and no later than 11/1/2020. Per CSU extension, control of Russian knapweeds requires a multi-pronged treatment approach as a single control strategy will not likely be sufficient. Areas treated for Russian knapweed should be reseeded with desirable perennial grasses in the fall to compete with the treated knapweed.
