On June 23, 2020, COGCC Staff John Heil conducted an environmental field inspection of TEP ROCKY MOUNTAIN LLC (TEP operator #96850) Location ID 323789 MV 29-27 and Spill/Release Form 19/19A Doc #2148673.

Comment: 4/13/2014 TEP (Formally WPX) submitted a Form 19 when a small hole in a condensate tank released 66 bbl of fluids into the secondary containment structure. It was reported that a vac truck was able to recover 100% of the fluids and there were no impacts outside of secondary containment. See SPILL/RELEASE REPORT Doc #2148673 for more information. 6/23/2020 J.Heil conducted an inspection in and around the tank battery where the spill/release occurred. There were no impacts in or around the tank battery and the secondary containment structure was intact with no tears or holes at time of inspection.
